Notes to Financial Statements

1 STATEMENT OF ACCOUNTING POLICIES

General Accounting Policies

The general accounting policies recognised as appropriate in the preparation of these financial statements are:

- The measurement base is historical cost
- Reliance is placed on the fact that the Club is a going concern
- Accrual Accounting is used to match expenses and revenue

Differential Reporting

These financial statements have been prepared under the basis that Lyall Bay Surf & Life Saving Club is exempt from certain requirements of financial reporting standards as a qualifying entity, as it has no public accountability (other than to Members) and is not large as defined by the framework for differential reporting.

Fixed Assets and Depreciation:

Depreciation of assets has been used on a fixed percentage of cost on a reducing balance except where additions have been made during the year. Additions are depreciated on a proportion of the annual rate based on the number of months owned. Fixed assets are valued at cost less depreciation to date.

The depreciate rate for Buildings has been increased to 12.5%, from 5%, for the 2008 and future financial years. This change reflects the anticipated useful life of the No1 clubhouse not extending beyond 2010 / 2011, when a new clubhouse is expected to be completed.

Goods and Services Tax

These financial statements have been prepared on a GST exclusive basis.

Contingent Liabilities

At balance date there are no known contingent liabilities. Lyall Bay Surf & Lifesaving Club has not granted any securities in respect of liabilities payable by any other party whatsoever.
